- ❖ This Calendar does not include Courses offered by independent accredited CLE providers;
- ❖ The Council of the Bar may accredit any other course during the course of the year;
- ❖ All advocates are required to pay 5 days in advance to facilitate the logistical planning except when the training is free of charge;
- ❖ Registration shall be done on the RBA www.rwandabarbar.org.rw through the RBA Management Information System/MIS;
- ❖ All advocates are required to inform the RBA's Secretariat of any CLE program they have attended during the previous month;
- ❖ The CLE training can be organized in any area of the Rwandan territory if at least 30 advocates request for that training;
- ❖ Any changes to this calendar will be communicated to the membership via email and the RBA Website;
